

Southern California Junior All American Football & Cheer 2025 Family Code of Conduct FOOTBALL & CHEER

I will not use profanity, smoke (including vaping products), use tobacco chewing products or consume alcohol during any practice or home/away game in accordance with the SCJAAF Conference rulebook.

I will not have any alcohol or illegal drugs in my possession or vehicle while attending any practices, any city park facility, home/away games at any High School or Chino Hills Junior All American Football events.

I understand that pets are not allowed on any SCJAAF school designated property. (Excludes service animals with proper certification shown upon request).

I will not shout or make derogatory remarks directed towards game officials, coaches, players, cheerleaders, volunteers, conference officials or league officials.

I will not make any comments including posting any comments on social media that are determined to be detrimental to the Chapter, Board, and/or SCJAAF Conference.

I will not have any type of violent physical or verbal contact or make reference and/or threat to do harm by violent physical contact with any child, player or adult.

I understand as Parents, Guardians, Family Members and my guest we may watch practices or games from designated areas only. Unauthorized persons will not be allowed on the practice or game fields. Parents are not to coach from the sidelines; please leave the coaching to the coaches.

I understand that if I have any questions, comments or concerns regarding my child's team that I must wait the mandated 24 hours following the game **before** addressing the team Athletic Director, and/or Head Coach.

I understand the Commissioner and/or Chapter Athletic Director has the right to question and/or intercede on behalf of the league or parents of any child in the Chino Hills JAAF program.

I understand that I, my family, and guests represent CHJAAF Football/Cheer both on and off the field. I will not make any derogatory remark(s) towards any cheerleader, player, child, trainer, coach, Conference member, Board member, referee, or adult verbally or on any platform; this includes, but not limited, to social media posts, group chats, and texting.

I understand the practice is required for the Competition Cheer squad and multiple missed practices may result in my dismissal from the Competition Cheer squad performance. Practice is a vital part of my development and safety.

I understand that if I have questions, comments, or concerns regarding my child's cheer squad that I must first address the Cheer Coordinator, and he/she will in turn address the coaching staff and work to resolve any issues as needed.

I acknowledge that a cheerleader can only cheer for one game squad, regardless if they have multiple siblings on different teams. Exception is in the Super Bowl game.

I understand that a cheerleader may not wear makeup, have acrylic nails or nail polish, except as allowed during competition for Pee Wee and Midget cheerleaders per conference rules. I understand jewelry may not be worn, expect for medical or religious reasons as allowed by Conference rules.

I understand the Cheer Coordinator and/or Chapter Commissioner has the right to questions and/or intercede on behalf of the league or parents of any child in the CHJAAF program.

I understand that SCJAAF and/or CHJAAF has the right to suspend or eject my membership or any member of my family from the organization for rule violations in accordance with its bylaws. **Any suspension includes all CHJAAF AND**

SCJAAF activities, including but not limited, to games, practices, and team events.

I understand that the SCJAAF conference rulebook and CHJAAF bylaws govern me and any violation can result in suspension or termination from the program.

I understand that multiple violations of the Code of Conduct may result in permanent suspension from the CHJAAF program. This includes violations from previous season(s).

I understand parents are required to participate 100% in CHJAAF chapter fundraisers, or opt to BUYOUT at \$325. In addition, I understand the BUYOUT pertains to Chapter fundraising only, and does not include TEAM fundraising events. Chapter fundraising allows us to cover additional costs, such as equipment certification, city fees for practice lighting and field use, CVUSD high school stadium fees for home games, and other related costs.
