Coaching Code of Conduct- 2025

I hereby Pledge to live up to my Chino Hills Junior All American Football and Cheer (CHJAAF) certification and to the Code of Conduct set forth by CHJAAF and Southern California Junior All American Football and Cheer (SCJAAF) conference.

I will treat all volunteers with respect.

I will place the emotional and physical well-being of my players ahead of a personal desire to win.

I will lead by example in demonstrating fair play and sportsmanship to all my players. I will not run up the score against any opponent.

I will do my best to provide a safe playing situation for my players. I will treat all players with respect.

I will not cancel or relocate a scheduled practice without 24-hour prior approval from the COMMISSIONER and/or President.

I will not deviate from the chapter approved uniform at said times including Picture Day and games. Any uniform additions (patches, etc.) must be approved by the President and Commissioner.

I understand the Commissioner and Chapter Athletic Director will place players in their correct division based on weight/age certification.

I will organize and structure practices so as to challenge, instruct and prepare players for success on and off the field.

I will adhere to the 10-play minimum play rule in accordance with the conference rulebook AND the 5-play rule for all Playoff Games in accordance with SCJAAF conference rulebook. *I further realize that deviation from this rule will result in player "starting" the next game, getting the missed plays from the previous game and a minimum of 10-plays in the same game.*

I will provide an environment for my team that is free of drugs, tobacco, and alcohol in accordance with all Chino Valley Unified School District policies and those policies of school districts of my opponents. I will refrain from their use at all CHJAAF/SCJAAF football and cheer events.

I understand I am required to complete and certify in the following mandatory coaching clinics, etc.: A) Conference mandated coaching clinics; B) Chapter mandated coaching clinics; C) Conference Online Certifications. All documentation must be provided to the Chapter Commissioner before the start of the season and being allowed on the field to coach or interact with players.

I understand I am responsible for all equipment provided to me by CHJAAF and all equipment must be returned at the end of the season or last scheduled equipment day whichever comes first. Any missing equipment will result in my equipment deposit being FORFEITED entirely or partially refunded.

I will be knowledgeable and abide by the rules of SCJAAF and CHJAAF football. I will act in accordance with these rules including the Coaching Code of Conduct, all Board policies, objectives and bylaws. *Any violation will lead to suspension AND conference fine.*

I will not argue with game officials, conference officials, league officials or opposing teams. I will conduct myself calmly when discussing rule interpretation and not shout derogatory remarks. Continued arguing will lead to suspension by the Chapter Commissioner.

I understand any physical or verbal abuse with anyone will result in immediate suspension from the program by the Chapter Commissioner. Suspension includes all practices Chapter events, games and game day activities.

I understand that unsportsmanlike behavior will lead to my suspension from a game. I understand that violating the rules of conduct will also lead to my suspension from the CHJAAF Chapter. I understand that in these instances I will be required to appear before the DISCIPLINARY COMMITTEE to explain my actions and the DISCIPLINARY COMMITTEE may take whatever action it deems necessary including termination from the program.

I understand that I am responsible for any fines that are levied by the conference including *any* game day fines. Said fines must be paid 48 hours prior to the following game or I will not be allowed to coach until fines are paid. (Appeals notwithstanding.)

I agree and understand that if suspended, denied participation or banned by SCJAAF OR CHJAAF that I will not be allowed to attend any SCJAAF/CHJAAF event including but not limited to practices AND games (home or away) during the suspension period.

I understand my Team Athletic Director is responsible for a player's well-being and has the final say whether a player will return to a game or practice. My Team AD may consult the Chapter AD and/or Commissioner in these situations.

I will attend all CHJAAF events, to the extent possible, including but not limited to equipment handout, equipment turn-in, Conditioning Camp, Parent Information Night, scheduled games, practices, scrimmages, coaches' meetings, picture day, Opening Day, Chapter Kick-Off Potluck, Halloween Potluck and Team Banquet.

I understand the Commissioner and/or Chapter AD has the right to question and/or intercede on behalf of the league or parents of any child in the CHJAAF program.

I will remember that I am a youth sports coach and that the game is for children not adults.

I understand that I must abide by CHJAAF, SCJAAF conference and opponent chapter rules regarding COVID-19. This includes but is not limited to: Wearing masks, no extra people on the field (adults and/or kids), no team members under the tent or around the team area until the previous game has ended and maintaining social distancing. Failure to do so will result in fines levied against my team.

Your field pass allows you field access during your team's practice, scrimmage, game day and game time. It is nontransferable. The conference certified badge must be worn and be visible at all times when on the field. You must follow all conference and/or chapter field requirements, at home and away games, or your field pass will be revoked.

The field pass does not allow you access to game day fields when your team is not playing.

I understand that violation of any of the above will result in my suspension and/or termination from the CHJAAF program.
